Mr. Weah has forwarded your letter dated September 3, 2015, sent by email. Please be advised that I represent George Weah. This communication should not be interpreted, nor is it in any way an authorization for service of any Petitions, or any other pleadings filed by your client on my office.

It is not clear what information has been shared with you, but the minor child has been supported by Mr. Weah, in the past, for which there is documentation. In fact, an offer has been made to continue support, based upon the Virginia Child Support guidelines. It is Mr. Weah's understanding that his daughter resides in Virginia. In fact, the minor child's mother is represented by Ms. Anneshia M. Grant, Esq. in a child support matter currently in the Juvenile and Domestic Relations Court for Fairfax County, Virginia. Mr. Weah has not been served in that matter, but has offered to resolve the payment of child support. Your client has refused any support for the minor child from my client.


